



In accordance with the provisions of Article 26 of the Statute of the **WORKERS' FOOTBALL CLUB SPLIT 1912**, OIB: 16120959649 (hereinafter: the Club), and in connection with the proposal of the Club's Board of Directors under Articles 34, 14 and 15 of the Statute, the Club Assembly adopts the following

RULES

ABOUT MEMBERSHIP FEES FOR REGULAR CLUB MEMBERS and ABOUT MEMBERSHIP FEES IN THE CLUB'S FOOTBALL SCHOOL

This Ordinance determines the obligation to pay and the amount;

- A) membership fees for all regular members of the Club and
- B) membership fees in the Club's Football School (hereinafter referred to as: ŠN).

A)

1 . Only natural persons and legal entities of legal age who support the activities of the Club can become regular members of the Club , with the fact that legal entities then obtain membership in the Club through an authorized representative appointed by a person authorized to represent that legal entity.

3. A regular member of the Club has all rights and obligations in accordance with the provisions of the Statute.

4. A regular member of the Club is obliged to pay membership fees in the amount prescribed by these Regulations, unless otherwise decided by the Club's Board of Directors.

5. A regular member of the Club is obliged to pay the membership fee once a year (annual membership fee), in the first year no later than 30 days from the date of receipt of the positive decision of the Club's Board of Directors on admission to membership (according to the previously submitted written application form). For each subsequent year, he is obliged to pay no later than the end of March of that year. The application form is submitted on the prescribed form, which forms part of these Regulations.

7. The membership fee is paid exclusively to the account of the Club with HPB dd no. IBAN: HR3523900011101456551.

8. With the funds collected on the basis of paid membership fees, the Club finances the activity and implementation of the Club's and ŠN's work program.

9. The membership fee is €40 per year.

10. Regular members of the Club are obliged to keep a copy of the confirmation of payment of the membership fee to the Club as proof of payment, and submit the same to the Club upon request.

11. Membership in the Club shall terminate in accordance with the provisions of Article 18 of the Statute, as follows:

- by the termination of the Club's existence, - by resignation, on the day of submission of a signed declaration of resignation from membership to the Board of Directors, - by an oral declaration of voluntary resignation from membership before the Board of Directors, on the day of giving the declaration, - exclusion due to violation of membership obligations and responsibilities, - exclusion due to non-payment of membership fees for more than 6 months from the due date, - death of a member.

B)

1. **A student of the Club's Football School** becomes a member by submitting a completed and signed application form for a minor under the age of 14 by their parent or guardian, and for a minor over the age of 14, the legal representative or guardian gives written consent to sign the application form. Application forms (with consent) are submitted in person to the head of the Football School or by registered mail to the Club. The information in the application form must be accurate, and the signatory of the application form is responsible for its accuracy. The application form and consent are submitted on the prescribed form, which forms part of these Regulations.

The costs of registration and re-registration of the participants of the ŠN with the competent football association are borne by the Club.

2. Participants of the ŠN RNK SPLIT 1912 have rights and obligations towards the Club in accordance with the provisions of the Statute.

3. A student of the Club is obliged to pay membership fees in the amount prescribed by these Regulations, unless otherwise decided by the Club's Board of Directors.

4. With the funds collected on the basis of paid membership fees, the Club finances the activity and implementation of the work program of the ŠN and the Club.

5. All members of the ŠN pay membership fees for 11 months of the year (no payment is made for July).

6. The member of ŠN is obliged to pay the membership fee from the month of the year in which he became a member of the Club, and the membership fee is paid no later than the 10th of the month for the current month.

7. The membership fee is paid exclusively to the account of the Club with HPB dd no. IBAN: HR3523900011101456551.

8. Membership fees for members of the ŠN Club are paid in monthly installments in the following amounts:

- for one participant: €60,

- for the second and each subsequent participant from the same family: €20.

9. In the case of a one-time payment for the entire year, the annual membership fee is €600, or for the second and each subsequent participant from the same family: €220.

10. ŠN members are obliged to keep a copy of the confirmation of payment of the ŠN membership fee as proof of payment, and provide the copy to the head of the ŠN for inspection upon request.

11. The monthly membership fee does not include: travel costs to competitions, camps, excursions, costs of official club equipment, costs of referees/delegates at matches or other costs of any other activities outside the official Club grounds.

12. The obligation to pay the ŠN membership fee ceases on the date of the ŠN member's removal from the list, exclusively by written notification from the parent or guardian delivered to the ŠN leader or sent by registered mail to the Club.

This Ordinance shall enter into force on the date of its adoption.
