

## Privacy Statement

The owner of the website rnksplit1912.hr (hereinafter referred to as the "website") is the Association/

Club RNK Split 1912 (hereinafter referred to as "we", "us", "our", etc.). We have created this privacy statement to show that we care about the privacy of our users and to inform them about the methods of collecting and processing personal data on this website.

Please read this Statement carefully to learn how we collect, process, store or otherwise use your personal information.

### Data collection

Personal data is any information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

We collect your personal information only when you voluntarily provide us with such information.

You should keep in mind that non-personal information and data may be automatically collected through our Internet servers or through the use of "cookies".

Examples of information about your use of the site include: the most visited and most viewed pages and links on our website, time spent on the page, the most popular keywords that lead users to our site, your IP address, information collected through cookies, data of your device such as hardware settings, system acvnos, browser type, etc.

### Data processing

We use the information we collect about you for one or more of the following purposes:

- To personalize your user experience (collected information helps us better respond to your individual needs);
- In order to improve our website (we constantly strive to improve the offer of our website based on the feedback we receive from our visitors);
- To establish a primary channel of communication with you;
- For the purpose of occasionally sending emails (which may include occasional news (if you wish), updates, information about similar products or services, etc.)

### Links to third parties

We do not offer or provide any third party services or products on our website.

## Why your data?

We use physical, technical and organizational security measures to protect the personal information you submit through this website. We are constantly upgrading and strengthening our security technology.

We limit access to your personal information to only those employees who need to know that information to provide you with certain benefits or services.

## Data storage and retention period

We will retain your personal data for the duration of your business relationship with us. We will regularly delete personal data you have provided to us for business or contact purposes after 12 months from the date you provided it to us.

## Rights of individuals

You have the right to have the personal data we hold corrected if it is inaccurate. You can also, with certain exceptions, request that we erase your data or stop processing it. You can request that we stop using your personal data for direct marketing purposes. In many countries, you have the right to lodge a complaint with the competent data protection authority if you are not satisfied with the way we handle your personal data.

## Notification of a personal data breach

In the event of a personal data breach, we will notify you and the relevant supervisory authority by email within 72 hours of the extent of the breach, the data involved, the potential impact on our services and our planned measures to secure the data and limit any adverse effects on individuals.

We will not send you a notice of violation in the following cases:

- if there are technical and organizational protection measures (such as encryption) that have been applied to personal data affected by a personal data breach, which make this data unintelligible to any person who is not authorized to access it;
- if we have taken subsequent measures to ensure that a high risk to the rights and freedoms of individuals is no longer likely to occur;

- if this would require a disproportionate effort (in which case we will inform you through the media or similar equally effective measures).

Personal data breach means a security breach that leads to the unintentional or unlawful destruction, loss, alteration, unauthorized disclosure or access to personal data transmitted, stored and processed in connection with the provision of our services.
